

CURICULUM VITAE

Dr. Stjepo Pranjić was born in Bosnia and Herzegovina, where he completed elementary school and grammar school in 1980. After completing the grammar school, Stjepo Pranjić graduated from the University in Sarajevo in 1984 and in the same year enrolled in postgraduate studies at the Faculty of Law: constitutional-legal political department. After graduation, mr. Pranjić defended his doctoral dissertation at the Faculty of Law in Sarajevo and was already evaluated by a competent expert public as an expert with an enviable and diverse experience. Given that he has been working in the field of state law, Stjepo Pranjić began to perform professional activities in the state administration as a legally authorized person for performing certain legislative and administrative activities. Dr. Pranjić has been performing the **Legislative Activity** as a representative in the HR of PA of BiH since 1996, and in this regard he drafted the *Law on Competition and the Law on Consumer Protection of BiH*. Dr. Pranjić performed the **Administrative Activity** as an official person who is legally authorized to manage an organization with public authority by taking material actions and passing administrative acts (e.g. *Minister of Justice and Administration, Secretary of the Government, Head of the Archive of (F) BiH, PRESIDENT AND MEMBER OF THE COUNCIL OF COMPETITION OF BOSNIA AND HERZEGOVINA JUL 2005 – PRESENT – 15YRS*, Expert at Agency for Development of Higher Education and Quality Assurance (HEA) Mar 2010 – Present – 10 yrs; *et al.*).
