Notification on concentration of undertakings

Pursuant to Article 42 paragraph (1) item d), in accordance with Articles 12, 14, 16, 17 and 18 of the Competition Act («Official Gazette of BiH», No. 48/05, 76/07 and 80/09), solving upon Notification on concentration of the undertaking "MERCATOR BH" Wholesale and retail sale trade d.o.o. Sarajevo, Ložionička16, 71000 Sarajevo, represented by attorney Marjana Kulenović, Vase Pelagića 48, 78000 Banja Luka, filed on 24th October 2011 under number: 05-26-1-024-II/11, Council of Competition at its 23rd (twentythird) session held on 8th December 2011, has issued

DECISION

- 1. Concentration that would arise on the market of retail sale of food and non-food products and consumer goods in the territory of the Federation of Bosnia and Herzegovina, by signing long-term contract of lease (sublease) of retail commercial buildings of undertaking "DRVOPROMET" limited liability company for trade, import, export, transport in road traffic Sarajevo, Blažuj bb, 71000 Sarajevo, with the undertaking "MERCATOR BH" wholesale and retail trade d.o.o. Sarajevo, Ložionička 16, 71000.
- 2. This Decision on concentration in entered into Registry of concentrations.
- 3. This Decision is final and shall be published in "Official Gazette of BiH" official gazzetes of Entities and Brcko District of Bosnia and Herzegovina.

Exposition

Council of Competition received Notification on concentration on 24th October 2011 No.: 05-26-1-024-II/11, (hereinafter: Notification) of the undertaking "MERCATOR BH" d.o.o. wholesale and retail trade d.o.o. Sarajevo, Ložionička 16, 71000 Sarajevo (hereinafter: Applicant or MERCATOR BH) which will arise by signing long-term contracts of lease (sublease) of retail commercial buildings, in terms of Article 12 paragraph (1) item b) of the Competition Act, of the undertaking "DRVOPROMET" limited liability company for trade, import, export, transport in road traffic Sarajevo, Blažuj bb, 71000 Sarajevo (hereinafter: DRVOPROMET).

Having analysed filed Notification, Council of Competition found it was not complete, in terms of Article 30 paragraph (1) of the Act and Articles 9 and 11 of the Decision on Notification and criteria for assessment of concentration of undertakings («Official Gazette of BiH», No 34/10), and requested supplements thereof in accordance with the Article 31 of the Act, document No: 05-26-1-024-4-II/11 of 11th November 2011.

Applicant submitted the requested documentation on 16th November 2011, submission No.: 05-26-1-024-5-II/11.

After completion of Notification, Council of Competition issued a Confirmation of complete and adequate Notification No. 05-26-1-024-12-II/11 of 29th November 2011, in accordance with Article 30 paragraph (3) of the Act.

In accordance with Article 30 paragraph (2) of the Act, the Applicant stated that it has not filed nor has an intention to file a request for concentration assessment to authorized authroities outside Bosnia and Herzegovina.

According to Article 16 paragraph (4) of the Act, Council of Competition published a Notice on submitted Notification No.: 05-26-1-024-6-II/11 of 23rd November 2011, in daily press on 24th November 2011, inviting all interested parties to submit written comments regarding the intended concentration. There were no commnets on the Notice submitted by interested parties.

The Notification was filed in statutory deadline, in accordance with Article 16 paragraph (1) of the Act.

During the concentration assessment procedure, Council of Competiton established the following facts:

1. Participants to the concentration

Main registered activities of the undertaking DRVOPROMET are wholesale and retail of food and non-food products and other consumer goods.

Undertaking DRVOPROMET has 71 retail shops merely in the area of Federation of Bosnia and Herzegovina.

Obligation to notify concentration

The obligation to notify concentration of undertakings exists if the cumulative requirements of Article 14 paragraph (1) items a) and b) of the Act are fulfilled, i.e. if total annual turnover of all parties to the concentration realized through the sale of goods and / or services on the world market is KM 100,000,000.00 according the balance of the year preceding the concentration, and if the total annual turnover of at least two parties to the concentration realized through the sale of goods and / or services on the market of Bosnia and Herzegovina is at least KM 8,000,000.00 in the final account in the year preceding the concentration, or if their combined share in the relevant market is greater than 40.0%.

According to the data (Table 2) total turnover of the undertaking MERCATOR BH on the market of Bosnia and Herzegovina in 2010 is (..)** KM (including turnovers of the affiliates of the undertaking MERCATOR BH of (..)** KM, undertaking Intersport BH d.o.o. Sarajevo of (..)** KM, and undertaking Modiana d.o.o. Sarajevo of (..)** KM earned in Federation of Bosnia and Herzegovina, as well as total turnover of (..)** KM of the undertaking M-BL d.o.o. Banja Luka earned in Republic of Srpska.

In the case when the concentration from Article 12 paragraph (1) of the Act applies to a merger or acquisition of part or parts of one or more business entities, regardless of whether these parts have a status of legal entity, when calculating income under paragraph (1) of Article 14 of the Act, only the income of those parts of the undertaking that are the subject of the concentration control shall be calculated.

Annual turnovers of the parties to the concentration are total revenues (excluding value added tax and other taxes), within the meaning of Article 9 item h) of the Decision on notification and assessment of concentration of the undertakings.

Based on these data on the total annual turnover (Table 2), within the meaning of Article 14 paragraph (2) of the Act, it was found that the parties to the concentration were required to submit Notification.

2. Legal framework of the concentration assessment

During the procedure of the assessment of the concentration Council of Competition applied the provisions of the Act, Decision on determining the relevant market ("Official Gazette of BiH" no. 18/06 and 34/10 and Decision on notification and criteria for assessment of concentration of undertakings.

Council of Competition, in accordance with Article 43 paragraph (7) of the Act, calculating the total annual turnover of the participants to concentration, used the criteria and standards of the European Commission Information about the calculation of total turnover in accordance with Council Regulation (EEC) No. 4064/89 on the control of concentrations of undertakings.

3. Legal basis and form of the concentration

As the legal basis of the concentration Applicant submitted Framework Agreement on lease of commercial facilities and takeover of other rights and obligations, signed on 20th October 2011 in Sarajevo between undertaking MERCATOR BH (represented by Neven Hadžisulejmanović, Director) and undertaking DRVOPROMET (represented by Fehim Baždarević, Director).

This Framework Agreement regulates the relations on the long-term lease of 63 retail facilities, office space and warehouse space (Blažuj) in the Federation of Bosnia and Herzegovina for a period of (..)** years, buying and selling stocks in the buildings, takeover of lessor's workers and commercial cooperation. According to data from the Framework Agreement the total surface of leased office space is gross (..)** m2 (63 retail facilities (..)** m2 total area, and a total area of office space (..)** m2 and a total warehouse space surface (..)** m2).

Since the concentration is defined as 'asset deal' or takeover of the certain defined assets (business) of undertaking DRVOPROMET, in that sense there is no change in the ownership structure of the undertaking DRVOPROMET.

After implementing concentration the undertaking DRVOPROMET will continue to engage in commercial activity in retail stores (supermarkets) that are not subject of this concentration.

Legal form of the concentration pursuant to Article 12 paragraph (1) item b) 3) of the Act is the acquisition of the dominant influence of the undertaking (Mercator BH) over parts of other undertaking (DRVOPROMET) concluding contract of lease (sublease) in accordance with the provisions of the Act.

4. Relevant market of the concentration

The relevant market, in terms of Article 3 of the Act and Articles 4 and 5 of the Decision on determining the relevant market, is the market of certain products / services that are the subject of business operation in a particular geographic market.

According to Article 4 of the Decision on determining the relevant market, relevant market comprises all products and / or services that consumers and / or users consider mutually substitutable, under acceptable conditions, especially bearing in mind their essential characteristics, quality, common purpose, usage, sale conditions and prices.

Furthermore, according to Article 5 of the Decision on the determining the relevant market, the relevant market in the geographical sense includes the whole or a substantial part of the territory of Bosnia and Herzegovina in which the undertakings operate in the sale and / or purchase of the relevant product under equal or sufficiently homogeneous conditions and which are significantly different from the conditions of competition on neighboring geographic markets.

In this case, relevant market of products and/or services is the market of retail sale of food and non-food products and consumer goods.

Since the participant to the concentration undertaking DRVOPROMET operates only on the territory of Federation of Bosnia and Herzegovina, relevant market in geographical sense is considered to be territory of Federation of Bosnia and Herzegovina.

Consequently, relevant market of the concentration is the market of food and non-food products and consumer goods on the territory of Federation of Bosnia and Herzegovina.

Analysing relevant market from the aspect of consumers and in accordance with practice of European Comission, Council of Competition found it necessary to analyse effects of the concentration on lower level, i.e. area of cantons/cities of Federation BiH where retail outlets of the participants to concentration overlap.

5. Analysis of the relevant market

Council of Competition in the course of the evaluation of the concentration required additional information from the applicant and the Agency for the financial, IT and Mediation Services Inc. Sarajevo, Ložionička no. 3, Sarajevo in relation to turnover earned in the relevant market that have been submitted on 12th February 2011(submission number 05-26-1-024-18-II/11) and on 1st December 2011 (submission number 05-26-1-024-15-II/11).

According to the Agency for the financial, IT and Mediation Services Inc. Sarajevo, Ložionička no. 3, Sarajevo (AFIP), the total turnover of the undertaking in the Federation of Bosnia and Herzegovina in the activities of retail sale of food, and nonfood products and consumer goods in 2010 amounts to 3,422,075,235.00 KM.

According to data from the Notification MERKATOR BH in Federation of Bosnia and Herzegovina operates in five regions, with twenty one (21) business units in the following cities:

- region Sarajevo with two (2) hypermarkets and six (6) supermarkets and one (1) market;
- regiion Tuzla with one (1) hypermarket and four (4) supermarkets (Tuzla, Lukavac, Živinice);
- region Herzegovina with one (1) hypermarket (Mostar), two (2) supermarkets (Mostar, Čapljina) and one (1) market;
- region Krajina with one (1) supermarket (Cazin);
- region Srednja Bosna and Zeničko-Dobojski kanton with one (1) supermarket (Vitez) and two (2) markets.

According to data from the Notification, sixty three (63) business units of the undertaking DRVOPROMET in Federation of Bosnia and Herzegovina are subject of the concentration in the following cities:

- Sarajevo (Ilidža, Vogošća, Hadžići) with one (1) hypermarket and one (1) supermarket and fourty (40) markets;
- Sanski Most with one (1) supermarket;
- Zenica with seven (7) markets;
- Trnovo with one (1) market;
- Ilijaš with four (4) markets;
- Visoko with three (3) markets:
- Fojnica with one (1) market;
- Kakanj with one (1) market;
- Mostar with one (1) market;
- Ključ with one (1) market;
- Maglaj with one (1) market;
- Žepče with one (1) market.

Analysis of data on the number, type and geographic location of retail facilities of participants to the concentration indicates that through this concentration undertaking "MERCATOR BH" is primarily expanding its sales network by increasing its retail outlets of the "market" type because of its previous structure dominated by retail selling outlets of type "hypermarket" and "supermarket". From the given data it is also evident that there is no significant overlap in the cities and types of retail outlets, and therefore there is no new or strengthened existing dominant position in the market.

6. Assessment of the concentration

Analysing relevant data Council of Competition, in terms of Article 17 of the Act Law, has assessed that the implementation of the concentration will increase market share in the relevant market of the retail food, non-food products and consumer goods, but will not create and strengthen a dominant position.

Making a final decision, Council of Competition took into account the Applicant's plans about the benefits that will arise for consumers through increased market supply of consumer products, better quality, greater choice of products, and interactive access to a wider range of products and services.

In addition, the Council of Competition took into account the investments through the implementation of the concentration, which includes investments in modernization and development of retail facilities, the introduction of international and corporate business standards, training and stimulation of employment and the provision of modern and pleasant working conditions for employees.

Implementation of the transaction will bring immediate benefits for consumers:

- Lower priced products in order to lower the cost of procurement, warehousing, distribution and sales, as well as achieving economies of scale;
- Increasing the supply of products achieved through the introduction of product brands Mercator;
- Stability in the offer or the smooth supply of consumer desired product;

- Improving the quality of services delivered through the introduction of international and corporate business standards;
- Adjustment of supply requirements and purchasing power of local consumers.

Furthermore, Council of Competition found that on the relevant market, there are no legal / administrative barriers to entry, nor there are any required significant financial investment to start in retailing of food, and non-food consumer products, so that the participants to the concentration even after the implementation of the concentration could not to a large extent act independently of the actual or potential competitors.

Consequently, Council of Competition assessed the concentration compatible in terms of Article 18 paragraph (2) item a) of the Act.

7. Administrative tax

In accordance with Article 2 tariff number 107 item d) point 1) of the Regulation on administrative taxes related to procedural actions before the Council of Competition («Official Gazette of BiH», No. 30/06 and 18/11) the Applicant is obliged to pay administrative tax for this Conclusion in amount of 2.500,00 KM for the benefit of the Budget of institutions of Bosnia and Herzegovina.

8. Legal remedies

Appeal against this Decision is not allowed.

Unsatisfied party can initiate administrative procedure before the Court of Bosnia and Herzegovina within 30 days from the day of receipt or publication of this Decision.
